#### **READ, SIGN, DATE AND RETURN only if you choose to submit by paper**

If you are the parent or the student, by signing this signature form, you agree, if asked, to provide information that will verify the accuracy of your completed FAFSA form. This information may include a copy of your U.S. or state income tax forms that you filed or are required to file. Also, you certify that you

- will use federal and/or state student financial aid only to pay the cost of attending an institution of higher education,
- are not in default on a federal student loan or have made satisfactory arrangement to repay it,
- do not owe money back on a federal student grant or you have made satisfactory arrangement to repay it,
- will notify your school if you default on a federal student loan,
- understand that the Secretary of Education has the authority to verify information reported on the FAFSA application with the Internal Revenue Service and other federal agencies, and
- will not receive a Federal Pell Grant for more than one school for the same period of time.

If you purposely give false or misleading information, you may be fined \$20,000, sent to prison, or both.
