

## **COURSE OUTLINE** **Team and Community Building**

### **Course Description**

LS 220. Team and Community Building. 3 hours credit. This course will enable the student to understand effective collaboration by using various leadership strategies. Topics covered include communication, decision-making skills, conflict resolution, interpersonal relationships, and group cooperation. The student will engage in a team service-learning community project applying collaborative skills gained from the class.

### **Course Relevance**

The concepts learned in this course give the student skills that enhance abilities in team building, teamwork, and team leading in his/her communities or organizations.

### **Learning Outcomes**

The intention is for the student to be able to

1. Identify teaming-related theories, concepts, and principles
2. Communicate effectively with others in communities or organizations
3. Apply critical thinking skills in team and community situations
4. Participate successfully in a team
5. Identify the premise and principles of successful collaboration in communities and regions

### **Major Summative Assessment Task(s)**

These learning outcomes and the primary Learning PACT skills will be demonstrated by

1. Completion of a team simulation activity
2. Completion of a team community service-learning project that identifies and addresses a need in the community. The team will prepare a written report and give a presentation that will be evaluated on the structure of the project, content, creativity, and teamwork
3. Completion of a team consultant project. The team will study a “team” in the community. The team will prepare a report and presentation that will include feedback and recommendations to the “team” evaluated

### **Course Content**

  - C. Collaboration in a democratic society

  - C. Varied issues in collaborative processes

  - C. Collaboration principles and processes
- IV. Skills/Competencies – Actions that are essential to achieve the course outcomes:
  - A. Communicate more effectively with others
  - B. Apply oral, written, and listening skills in the team environment
  - C. Apply computer literacy
  - D. Use of analytical thinking in problem solving
  - E. Use a wide variety of tools and techniques to help address the specific needs of communities and regions
  - F. Participate successfully in a team setting
  - G. Demonstrate benefits and challenges of working in teams
